

## Investors Toolkit Tips & Tricks

### How to Email a PERT Report.

We have been asked how to email a PERT report from Toolkit. It would certainly be a useful function for the PERT Wizard of your club to be able to distribute the PERT Report to all members prior to a meeting.

There are three ways that I can think of right off hand. They will be addressed from the lowest cost (free) to the higher cost methods.

#### **Method 1 - A screen capture. Cost: Free.**

- Bring up the PERT of your choice.
- Shrink the Toolkit window to just enclose the PERT window within.
- Hold down the <ALT> key and then strike the <PRT SCR> key. The <PRT SCR> key is usually located in the top row of keys to the right of the Function Keys. This places the Toolkit window on the clipboard.
- Now simply paste the clipboard into your favorite word processing program, e.g., MS Word.
- Email the word processor document as an attachment.
- The results are shown in Figure I.

#### **Method II - Use SnagIt. Cost: \$35.00**

SnagIt is a smart little program available from TechSmith, [www.techsmith.com](http://www.techsmith.com). Many of our Toolkit and Prospector Tips have used SnagIt to capture views that enhance the explanations.

- Set SnagIt for Region Capture to the clipboard.
- Activate and click in the PERT window only the area that you want. This will capture the PERT without all the extraneous parts of the Toolkit window.
- Again, simply paste the clipboard into your word processor.
- Email the word processor document as an attachment.
- The results are shown in Figure II.

Perhaps you only need to send the quality portion of the PERT. Figure III is an example of just a small portion of the PERT. In this example, the cursor was included to point to a specific number that you would like to reference.

SnagIt can even be used to add notes and highlight to a capture. See Figure IV.

## How to Email a PERT Report (continued)

### Method III - Print the PERT using Adobe Acrobat. Cost: \$300 for this program.

Printing to Adobe is how PDF (Portable Document Format) files are created. It was used in many of our Tips and for this document. Should you have needs beyond the emailing of PERT tables, it could be a viable alternative. The last two sheets of this document show PERT printed as a PDF file. There are no Page or Figure numbers for these.
